

Official Call for a Mass Meeting of the  
Lancaster County Republican Party

As Chairman of the Lancaster County Committee of the Republican Party and pursuant to the Plan of Organization and as recommended and directed by the Committee, I, Michael Schoelwer, do hereby issue this notice and call for a Mass Meeting to be held in the Public Meeting Room at the Chesapeake Bank Training Center, 51 School St, Kilmarnock, VA 22482 starting at 7:00 PM local time on April 5, 2018 for the following purposes:

1. Elect a Chairman of the Lancaster County Republican Committee.
2. Elect members of the Lancaster County Republican Committee.

Qualifications for Participation

All legal and qualified voters of Lancaster County under the laws of the Commonwealth of Virginia, regardless of race, religion, national origin or sex, who are in accord with the principles of the Republican Party and who, if requested, express in open meeting either orally or in writing as may be required, their intent to support all of its nominees for public office in the ensuing election, may participate as members of the Republican Party of Virginia in its mass meetings, party canvasses, conventions or primaries encompassing their respective election districts.

Filing Requirements

Candidates for election as Chairman or Committee Members of the Lancaster County Republican Committee shall file a written statement of intention, by mail or in person to Michael Schoelwer, Chairman, or the Lancaster County Republican Committee, P.O. Box 1215, Kilmarnock, VA 22482 using the attached form. The form must be received no later than 8:00 PM April 2, 2018. Postmarks do not govern. More information may be obtained by contacting Chairman Schoelwer at (703) 434-2607. All candidates seeking membership on the Lancaster County Republican Committee are required to submit a \$10.00 pre-filing fee, with checks to be made payable to the Lancaster Republican Committee. For current members who have already paid their annual dues, no additional membership fee is required, but the \$10 fee should be sent with the pre-filing form.
