As Chairman of the New Kent County Republican Committee of the Republican Party of Virginia, and pursuant to the RPV Plan of Organization, I, Mark Daniel, do hereby issue this Call for a Mass Meeting on March 22, 2018 at the New Kent County Administrative Building, 12007 Courthouse Circle, New Kent, VA 23124 starting at 7:00 p.m. for the following purposes:

1. To elect members of the New Kent County Republican Committee (NKCRC) in compliance with the RPV Plan of Organization which requires each committee to reconstitute every two years with all members re-affirming their commitment to support Republican candidates,
2. To elect a Chairman for the New Kent County Republican Committee.

Registration begins at 6:15 p.m. and closes 10 minutes after the Mass Meeting is called to order. Persons in line 10 minutes after the Mass Meeting begins will be allowed to register. A Picture ID is required to register for the Mass Meeting. To complete registration, participants must sign the statement of intent on the Mass Meeting Filing Form.

Qualifications for Participation

All legal and qualified voters of New Kent County, under the laws of the Commonwealth of Virginia, regardless of race, religion, national origin, or sex, who are in accord with the principles of the Republican Party and who, if requested, express in open meeting either orally or in writing as may be required, their intent to support all of its nominees for public office in the ensuing election, may participate as members of the Republican Party of Virginia in its mass meetings, party canvasses, conventions or primaries encompassing their respective election districts.

In addition to the foregoing, to be in accord with the principles of the Republican Party, a person otherwise qualified hereunder shall not have participated in Virginia in the nomination process of a party other than the Republican Party in the last five years.

A single exception to the above shall be approved for a voter that renounces affiliation with any other party in writing, and who expresses in writing that he/she is in accord with the principles of the Republican Party and intends, at the time of the writing, to support the nominees of the Republican Party in the future. A voter who utilizes the foregoing exception, and thereafter participates in the nomination process of a Party other than the Republican Party, shall not have the benefit of the exception as identified in this paragraph thereafter.

A person, who has made application for registration and meets all other requirements of the Qualifications for Participation, but whose name does not appear on the local registration books solely because of the books having been closed in connection with a local election, will nevertheless be deemed a legal and qualified voter.

### **Filing Requirements**

**Candidates for election to the position of Chairman of the New Kent County Republican Committee shall file a written statement of intent to seek election as Chairman by 5:00 PM, EDT, March 15, 2018 and deliver the statement in one of the ways listed below: Postmarks do not govern.**
