Party Canvass of the Gloucester County Republican Party of the Republican Party of Virginia

As Chairman of the Gloucester County Republican Committee (GCRC) of the Republican Party of Virginia (RPV), and pursuant to the RPV Plan of Organization and as recommended and directed by the GCRC, I, Ashley C. Chriscoe, do hereby issue this call for a Party Canvass to be held at GOP Headquarters, 6888 George Washington Memorial Hwy., Gloucester VA 23061, or alternate location, on Saturday, March 5, 2022 starting promptly at 12:00 p.m. and ending promptly at 6:00 p.m. local time for the following purposes:

- A. Electing a Unit Chairman of the Gloucester County Republican Committee;
- B. Electing Members of the Gloucester County Republican Committee as follows:

Qualifications for Participation

All legal and qualified voters of Gloucester County under the laws of the Commonwealth of Virginia, regardless of race, religion, national origin or sex, who are in accord with the principles of the Republican Party and who, if requested, express in open meeting either orally or in writing as may be required, their intent to support all of its nominees for public office in the ensuing election, may participate as members of the Republican Party of Virginia in this party canvass, subject to the provisions in Article I of the RPV Plan of Organization. In addition to the foregoing, to be in accord with the principles of the Republican Party, unless otherwise stipulated by the appropriate Official Committee, a person otherwise qualified hereunder shall not have participated in Virginia in the nomination process of a party other than the Republican Party within the last five years. A single exception shall be approved for a voter who renounces affiliation with any other party in writing, and who expresses in writing that he/she is in accord with the principles of the Republican Party and intends, at the time of the writing, to support the nominees of the Republican Party in the future. Any voter that utilizes the foregoing exception, and thereafter participates in the nomination process of a party other than the Republican Party, shall not have the benefit of the exception thereafter. Party Canvass voters must present one of the forms of identification listed in Title 24.2-643 of the Code of Virginia in order to participate.

Filing Requirements

All candidates for election at said Party Canvass shall pre-file the applicable and properly completed "Official Gloucester County Republican Party Canvass Filing Form" including non-refundable filing fee(s) in the amount stated on the applicable filing form(s).

The "Official Gloucester County Republican Party Canvass Filing Form" and filing fee for Unit Chairman and Members must be delivered to and received by Pat Dunnington not later than Sunday, February 27, 2022, at 5:00 p.m. local time.

The Gloucester County Republican Party Chairman Mr. Ashley C. Chriscoe has designated that, on his behalf, ALL filings shall occur as follows: ALL "Official Gloucester County Republican Party Canvass Filing Form" forms and fees must be physically delivered, by mail on in person, to Ms. Pat Dunnington at 7215 Clements Avenue, Gloucester VA 23061 no later than 5:00 p.m. on Sunday, February 27, 2022. Postmarks shall not govern.

Cancellation

If not more than the number of persons to be nominated or elected shall file for any office, then such properly filed persons shall be declared nominated or elected as the case may be, and no election will occur for that office. If not more than the number of persons to be nominated or elected shall file for all offices listed for this Party Canvass, then all such properly filed persons shall be declared nominated or elected as the case may be, and this Party Canvass shall be cancelled. A notice of cancellation will be posted on the website of the Republican Party of Virginia www.virginia.gop
